8. The Competition finalists will be contacted by phone and via the tannoy system shortly after judging has finished at 15.30. The winners are to make themselves known to Racecourse staff in the Racecourse Office where they will then be shown to the Style Awards Pod and presented with their prizes at 16.15.

9. Six winners will be picked by an independent judging panel consisting of Laceby Manor Spa Director Alex Burnett, #Raceday presenter Frankie Foster and Showjumper Rosie Blossett.

10. The judges will be provided with all entry images. They will then choose the most 'unique and stylish' winner and agree. The Judges will be looking for the most unique and stylish outfit on the course based on the following criteria:

- a. Appropriateness of the outfit for wearing to racing
- b. Style, creativity and originality
- c. Inclusion of a Headpiece
- d. Attention to detail

11. The winners will be notified via email or telephone. Confirmation of acceptance of the prize must be made by Saturday 19<sup>th</sup> July 2025. Failure to claim the prize will result in disqualification and selection of an alternate winner. All reasonable efforts will be made to contact the winner before selection of an alternative winner is made.

12. In the event of any dispute regarding the Rules, conduct, results and all other matters relating to the Competition, the decision of the Jockey Club shall be final, and no correspondence or discussion shall be entered into.

13. The winners and their guests will be responsible for making their own travel arrangements to Summer Plate Ladies Day at Market Rasen Racecourse on Saturday 18<sup>th</sup> July 2026, Tom Jones live after Racing on Saturday 16<sup>th</sup> August 2025, Boxing Day racing on Friday 26<sup>th</sup> December 2025 and to the selected non feature days for hospitality prizes.

14. If for any reason any aspect of this Competition is not capable of running as planned, including by reason of infection by computer virus, network failure, bugs, tampering, unauthorised intervention, fraud, technical failures or any other cause beyond the control of the Promoter which corrupts or affects the administration, security, fairness, integrity or proper conduct of

this Competition, the Promoter may in its sole discretion modify or suspend the Competition or invalidate any affected entries. If an act, omission, event or circumstance occurs which is beyond the reasonable control of the Promoter and which prevents the Promoter from complying with these terms and conditions the Promoter will not be liable for any failure to perform or delay in performing its obligation.

15. The Promoter reserves the right to verify all entries and the winners and to refuse to award a prize or withdraw prize entitlement where there are reasonable grounds to believe there has been a breach of these terms and conditions or any instructions forming part of Competition entry requirements or otherwise where a participant has gained unfair advantage in participating in the Competition or won using fraudulent means.

16. The Promoter will not be responsible if the winner is unable to attend Summer Plate Ladies Day at Market Rasen Racecourse on Saturday 18th July 2026, Tom Jones live after Racing on Saturday 16<sup>th</sup> August 2025, Boxing Day racing on Friday 26<sup>th</sup> December 2025 and to the selected non feature days for hospitality prizes due to health or other reasons.

17. The Promoter will not be liable if Summer Plate Ladies Day at Market Rasen Racecourse on Saturday 18th July 2026, Tom Jones live after Racing on Saturday 16<sup>th</sup> August 2025, Boxing Day racing on Friday 26<sup>th</sup> December 2025 or non feature days for hospitality prizes is cancelled, delayed or suspended as a result of an act, omission, event or circumstance which is beyond the reasonable control of the Promoter.

18. The Promoter and its associated agencies and companies will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense or damage which is suffered or sustained (whether or not arising from any person's negligence) in connection with this Competition or accepting or using a prize, except for any liability which cannot be excluded by law (including personal injury, death and fraud) in which case that liability is limited to the minimum allowable by law.

19. This Competition is not open to employees of The Jockey Club, members of the judging panel, their immediate families, prize sponsors, agents, clients, suppliers, retailers, merchants or associates.

20. The Promoter reserves the right to amend, alter, vary, suspend or withdraw this promotion as the Promoter deems necessary in its absolute sole discretion.

21. The Promoter shall have the right in its absolute sole discretion to substitute any prize with one of equivalent or greater value. The prize or its alternative must be accepted as offered. No cash alternative will be offered in whole or in part in connection with this promotion.

26. If there are reasonable grounds to believe that there has been a breach of these terms and conditions by an entrant, The Jockey Club may, at its sole discretion invalidate the prize and disqualify the entrant from the Competition.

27. If any of these clauses should be determined to be illegal, invalid or otherwise unenforceable then it shall be severed and deleted from these terms and conditions and the remaining clauses shall survive and remain in full force and effect.

28. Any question concerning the legal interpretation of the rules will be based on English law and the courts of England will have exclusive jurisdiction unless you live in another part of the United Kingdom, in which case your local courts will have jurisdiction.
